# In accordance with the State Government subsidy, the definition of an approved Pensioner is a Pensioner who:

- Is and remains an eligible holder of a Queensland 'Pensioner Concession Card' issued by Centrelink, on behalf of the Department of Family and Community Services, or the Department of Veterans Affairs, or a Queensland 'Repatriation Health Card – For All Conditions' (Gold Card) issued by the Department of Veteran's Affairs; and
- Is the owner or life tenant (either solely or jointly) of the property which is located in Queensland, and which is his/her principal place of residence.
- Has, either solely or jointly with a co-owner, the legal responsibility for the payment of rates and charges as
  defined herein, which are levied in respect of the said property by the Local Government in whose area the
  property is situated.
