7.3.2 P&LM - 962390 - Forwarding IDAS application for a Material Change of Use to Sell Rainwater and Cartage of Plastic Tanks at 7 Crittenden Road Memerambi - Lot 314 FY175 - Applicant/Owner: KR & DA Kahler

Summary

- Application for Development Permit for Material Change of Use (Sales or Hire Premises)
- Proposed use defined as Sales or Hire Premises within Schedule 7 of the Kingaroy Shire IPA Planning Scheme
- Subject site included within the Rural Residential Zone (Rural Residential C Preferred Land Use Area) under the Kingaroy IPA Planning Scheme
- Subject site is improved by an existing Dwelling House and Rural Service Industry approved by the former Kingaroy Shire Council
- Proposed land use (Sales or Hire Premises) is listed as code assessable (inconsistent) within the Rural Residential Zone
- The Department of Transport and Main Roads (DTMR) are a Concurrence Agency as the subject site adjoins a State Controlled Road (Bunya Highway)
- The applicant states that approximately 72% of sales are derived from phone calls, e-mail communication and media advertisements
- The applicant also states that 3 to 4 people a day visit the subject site to view the range of rainwater and cartage tanks on display
- The rainwater tanks are currently located between the Bunya Highway frontage and the existing Dwelling House (display area is less than 500m²)

What services are provided by R&R Teams?

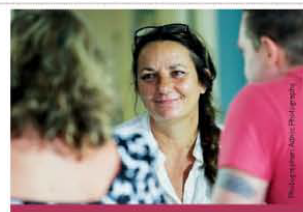
The R&R Teams delivers community outreach assessments and interventions to people who experienced trauma or were impacted by the disasters.

These teams also:

- facilitate access to the most appropriate care for individuals or groups exposed to disaster related trauma
- involve families, carers, significant others in care
- assist with resilience building for individuals presenting with trauma related concerns
- provide information and clinical advice.

What does the service cost?

The service is free for community members who were affected by the floods or cyclones.



Who will deliver these services?

R&R Teams are multidisciplinary teams operating out of a variety of community settings.

The teams are made up of a mixture of staff which may include:

- Nurses
- Occupational Therapists
- Psychologists
- Social Workers
- Psychiatrists
- Culturally and Linguistically Diverse (CALD) health workers
- Aboriginal and Torres Strait Islander health workers
- Administration Officers.

What is recovery?
Recovery refers to the way in which individuals regain their strength, composure and balance after losing something or someone, and are able to live, work, learn and participate fully in their communities.

What is resilience?
Resilience is a quality that enables individuals and communities to rebound from adversity, trauma, tragedy, threats, or other stresses - and to go on with life with a sense of mastery, competence, and hope.

5. Tractor Tattoo Walk 2012

What is Tractor Tattoo 2012?

Tractor Tattoo is a community arts and cultural project based around an event featuring the transformation of an old tractor into a playable musical instrument and the composition of an original piece of music for that event and a month of visual arts projects across the region. Funding for the musical instrument and composition component of the project has been provided by the Regional Arts Fund, Australia Council for the Arts and Arts Queensland. The project was developed from the South Burnett Regional Council's Arts, Culture & Heritage Policy and community consultation along with the Creative Regions team as part of the Creative Generators program.

Why the name Tractor Tattoo 2012?

A tractor is synonymous with a rural area whether you are a farmer, a tree changer or a child at school. Tattoo was chosen as the Edinburgh Tattoo is famous worldwide for its musical performance (a musical performance is a part of the project) and tattoos are also an art form.

What is actually going to happen?

From now until September 2012, we are working with community and art groups to make September 2012 a month where our community can celebrate the arts with a month long regional arts festival. During September the region will showcase exhibitions, events and a musical performance based around the Tractor Tattoo theme. On Saturday, 15 September, there will be a community concert based around the transformation of a tractor into a playable musical
